# **Legislative Update**

# H.R. 3852 Create Accountable Respectful Environments (CORE) for Children Act.

The act was initially filed by Congressman Dunn on June 6, 2023 with 11 original cosponsors. Rep. Gimenez, Caros A. [R-FL-28] was added as a cosponsor on July 26, 2023.

**H.R. 2955 - Stop Institutional Child Abuse Act** which is a companion Bill to **S. 1253** was filed initially in the House on April 27, 2023 with 3 co-sponsors. 9

additional co-sponsors were added in May 2023. 13 additional co-sponsors were added in June 23. 11 additional co-sponsors were added in July 2023.

Currently there are 18 Democratic co-sponsors and 18 Republican co-sponsors.

**S. 1353 - Stop Institutional Child Abuse Act** The bill was filed by Sen. Merkley, Jeff [D-OR] with 5 cosponsors on April 27, 2023. Two additional cosponsors were added in May 2023. Two additional cosponsors were added in July 2023.

## Protecting Sibling Relationships in Foster Care Act [H.R. 755]

The bill was filed by Rep. Bacon, Don [R-NE] on February 2, 2023 with three additional co-sponsors. Three additional cosponsors were added in May 2023.

**Foster Care Stabilization Act of 2023 [S.102]** The bill was filed by Sen. Fischer, Deb on January 26, 2023 with one cosponsor.

**Save Children's Coverage Act [H.R. 1316]** The bill was filed by Rep. Neguse, Joe on March 10, 2023. There are no cosponsors

**H.R. 3435 The Charitable Act** - was filed by Rep. Blake Moore on May 17, 2023 with three co-sponsors. 4 additional co-sponsors were added in June 2023. Reportedly the Act was filed by Rep. Chris Pappas [NH-01], Rep. Blake Moore [UT-01], Michelle Steel [CA-45] and Danny Davis [IL-07] on May 17, 2024. I have not been able to find an update or number for the bill. 14 additional co-sponsors were added in July 2023.

**S.566 Charitable Act** was filed by Sen. Lankford, James [R-OK] on February 28, 2023. There were 10 original cosponsors. 3 additional cosponsors were added in March 2023; 1 in April 2023 and 1 in May 2023.
