

# Executive Director's Report October 2023



# Information Sharing On Capitol Hill.

As planned, several member agencies of the Coalition of Residential Excellence came to Capitol Hill for visits with legislators on October 17<sup>th</sup> and 18<sup>th</sup>.

Those present included:

- Bill Frye, President and Maria Knapp, Vice President Florida Sheriffs Youth Ranches. They were accompanied by 32 youth and staff members.
- Sean Milner, Executive Director of The Baptist Children's Village in Ridgeview, Mississippi.
- Jimmy Harmon, President of Black Mountain Children's Home in Black Mountain, North Carolina.
- Paul Schandevel, Director of Child and Family Services, Children's Home, Inc. in Paragould, Arkansas.
- Thomas Robinson and James Turner, from Milton Hershey School in Hershey, Pennsylvania

The group representation by Florida Sheriffs Youth Ranches made a profound impact. The youth group adhered to the usual dress protocol on Capitol Hill. All of the boys were all wearing a coat and tie and the girls were wearing dresses. As a group, the youth were attentive, respectful and on their best behavior. They presented themselves and Florida Sheriffs Youth Ranches in a very favorable light.

Rep. Darren Soto, this year's recipient of the CORE Award for Policy Maker of the Year, engaged the students in dialogue at his office on Capitol Hill. He posed several questions which were thoughtfully answered by the youth.

Rep. Soto is also one of the original cosponsors of H.R. 3852 – Create Accountable Respectful Environments for Children Act. The bill currently has fifteen cosponsors. Twelve are from Florida, two are from Mississippi and one is from Texas.

To date, Rep. Steube is the only member of the United States House Committee on Ways and Means that has cosponsored H.R. 3852.

CORE's presence on Capitol Hill was important because of the on-going capacity crisis that leaves children in harm's way. The intent of H.R. 3852 is to help address the capacity issue by increasing the number of appropriate residential placement resources for children and keeping sibling groups together. The bill requires providing children a normalized home and community environment with opportunities for age-appropriate normalized extracurricular, enrichment, cultural and social activities and the same freedoms afforded peers living with families.

The legislation also includes a myriad of safeguards:

- Requiring the implementation of a trauma informed approach to care.
- Prohibiting the use of seclusion, mechanical or chemical restraints.
- Allowing the use of short-term physical restraint if approved in the agency's policies to prevent injury to self or others and the prohibiting the use of prone physical restraint.
- Requiring providers to have a system in place to alert staff person(s) if they

## S. 1353 - Stop Institutional Child Abuse Act


The Act has 16 cosponsors. Sen. Angus King and Sen Pete Ricketts signed on in October.
